As CATCO is a wholly-owned subsidiary of PT Chandra Asri Pacific Tbk ("PT Chandra"), PT Chandra has a deemed interest in all of the HSIL Shares in which CATCO has an interest. SCG Chemicals Public Company Limited ("SCG Chemicals") holds a 30.57% direct interest in PT Chandra and is therefore deemed to be interested in all of the HSIL Shares in which PT Chandra has an interest. SCG Chemicals is a 99.99% subsidiary of Siam Cement and accordingly, Siam Cement has a deemed interest in all of the HSIL Shares in which SCG Chemicals has an interest.
